### **Appointment of proxies**

- 1. As a member of the Cranbrook Sports Club, you are entitled to appoint a proxy to exercise all or any of your rights to attend, speak and vote at the AGM. You can appoint a proxy only using the procedures set out in these notes.
- 2. A proxy does not need to be a member of the Club but must attend the Meeting to represent you.
- 3. If you do not give your proxy an indication of how to vote on any resolution, your proxy will vote or abstain from voting at his or her discretion. Your proxy will vote (or abstain from voting) as he or she thinks fit in relation to any other matter which is put before the Meeting.
- 4. To appoint a proxy, email: <a href="mailto:carolinecannar@tiscali.co.uk">carolinecannar@tiscali.co.uk</a>. For a proxy appointment to be valid, your appointment must be received no later than 12 noon on 9 June 2017.

### **Changing proxy instructions**

- 5. To change your proxy instructions simply submit a new proxy appointment using the methods set out above. Note that the cut-off time for receipt of proxy appointments (see above) also apply in relation to amended instructions; any amended proxy appointment received after the relevant cut-off time will be disregarded.
- 6. If you submit more than one valid proxy appointment, the appointment received last before the latest time for the receipt of proxies will take precedence.

#### **Termination of proxy appointments**

7. In order to revoke a proxy instruction you will need to inform the Club by sending an email to <a href="mailto:carolinecannar@tiscali.co.uk">carolinecannar@tiscali.co.uk</a> to arrive no later than 12 noon on 9 June 2017, or delivered in person on the day of the AGM before 11.00 am.

If you attempt to revoke your proxy appointment but the revocation is received after the time specified then, subject to the paragraph directly below, your proxy appointment will remain valid.

Appointment of a proxy does not preclude you from attending the Meeting and voting in person. If you have appointed a proxy and attended the Meeting in person, your proxy appointment will automatically be terminated.
